Ho Lee Group Trust ("HLGT") held 65,941,771 Stapled Securities. Tan Hai Peng Micheal is a beneficiary of HLGT and is therefore, deemed to be interested in the 65,941,771 Stapled Securities held by HLGT.

Viva Industrial Trust Management Pte Ltd ("VITM") and Viva Real Estate Asset Management Pte Ltd ("VREAM") held 15,050,754 and 3,147,742 Stapled Securities, respectively. Tan Hai Peng Micheal owns 20.0% equity interest in Teck Lee Holdings Pte Ltd, which in turn owns 81.25% equity interest in Ho Lee Group Pte Ltd, which in turn owns 27.78% equity interest in Viva Investment Management Pte Ltd. Both VITM and VREAM are wholly-owned subsidiaries of Viva Investment Management Pte Ltd. Therefore, Tan Hai Peng Micheal is deemed to be interested in the 18,198,496 Stapled Securities held by VITM and VREAM.
